#### Dear Woodrockers

Firstly, we wish you all a happy and healthy **EASTER Season** and trust that those celebrating their various **HOLY DAYS** will find Peace and Blessings during this time.

As South Africa's LOCKDOWN continues, it is vital that we all take on maximum anti-Corona preventative measures and remember that we are all in this together.

Let us take care of ourselves, our families and our neighbours. . . . . . and "If you have to be anything – be KIND".

It has been a long time since our last newsletter (August 2019) wherein we confirmed the residents' acceptance of cameras in our area, but realised that this needed to be staggered into a Phase One, Two, Three and Four due to financial constraints.

Phase One was to consist of Licence Plate Recognition with Overviews that would be placed at both Lincoln and Riley booms, plus the intersection of Plymouth & Lincoln and the corner of Plymouth & Hillman. These two internal sites would enable us to determine the direction any particular BOLO car was travelling through our area. (BOLO = Be On Look Out).

The above application called for NINE cameras on FOUR poles and the chosen cameras are top-of-the-range which can operate in low light and even capture details if vehicles are going past at high speed. They are all currently solar-powered.

Having been given the go-ahead, VumaCam then embarked on applying for Wayleaves for the siting of the poles which needed to be done via Johannesburg Roads Agency (JRA) and City of Joburg (COJ).

The JRA then called for a further confirmation from residents via an electronic Survey to confirm that this installation had the majority support of the residents of the area. VumaCam thereafter duly submitted the Wayleave Applications to JRA.

The Wayleave acceptances took us into late October when it was discovered that due to an administrative error, two pole positions were incorrect.

The applications were corrected and re-submitted and JRA authority was given early December . . . . . together with a COJ notification that due to the upcoming Festive Season, no construction could begin until 16<sup>th</sup> January.

From late January construction began in earnest by VumaCam and their Third-Parties and the cameras were eventually put into TEST MODE, adjusted and accepted.

The Smart Surveillance (monitoring) system was then implemented by 24/7 Security, again tested, adjusted and accepted.

# WKRRA are now pleased to advise that our camera system went LIVE on 1<sup>st</sup> April 2020.

For your information and enjoyment we have attached a Snap Shot of each camera viewing herewith – all taken early morning when minimal traffic allows for 'circulation legality'.

Please note that due to POPIA we are not allowed to circulate any pics / video clips of identifiable people nor vehicles showing actual Licence Plates for identification purposes. I truly wish I could publish video footage of the many, many, many vehicles that stream over the Plymouth / Lincoln intersection without even a hint of stopping.

Please remember next time you travel through this intersection that you are on candid camera!

Camera footage is not available to residents and in the case of incidents is only available via VumaCam to SAPS and the PSIRA Registered Security Companies who monitor the cameras. Note that all VumaCam cameras throughout Johannesburg are linked and thus VumaCam can follow suspicious vehicles as they move through many areas, not merely one neighbourhood.

The more areas that join in this network, the greater chance citizens have of limiting crime in their areas.

Our Monitoring costs now kick in and thus we launch an urgent and intense appeal for more financial support of the WKRRA and the initiatives that are implemented via this forum. Our original costings on viability of the cameras were based on Stand-Alone Homes paying R400 per month and Gated Complex homes paying R250 per month.

Fees for registered Businesses operating from home are R600 per month.

WKRRA will negotiate an individual 'Seniors' rate for residents, but this must be <u>negotiated</u> <u>directly with Wendy</u> to allow for proper accounting systems to be implemented.

We do prefer Debit Orders as this lessens the onerous task of reconciliation and credit control for WKRRA (a registered non-profit company).

Please also note that all Resident Association <u>fees are payable in advance</u>, and that our current Financial Year runs from March/2020 to February/2021.

Our Cash Book / Contributor List is available monthly on our website <a href="www.woodrock.co.za">www.woodrock.co.za</a>. as we comply to a very strict transparency rule.

You will note that we recorded a <u>deficit in NINE months</u> of the past year, finally ending with a minimal positive balance of R3,150 at year-end.



Your monthly WKRRA contribution is used to cover the costs of the second 24/7 dedicated Armed Response vehicle, maintenance of the Boom operations including Mr Loo and Insurances as well as general security & maintenance issues within our neighbourhood, including monitoring of the 4x Phase One Security cameras.

The fees also cover Woodrock administration, database maintenance, banking and communications via Newsletters, What's App Groups and SMS Alerts; upkeep of the area via our garden service including entrance gardens, kerbsides, Lincoln cul-de-sac & the Chrysler Park area; liaison and meetings with third parties, Agencies, Authorities and our appointed Conveyancing Attorney and Urban Planner; monitoring of the School Project, development of the Precinct Plan and organisation of the Fibre Optic Project.

Other various services offered by the WKRRA, include, but are not limited to, maintaining a watchful eye on Town Planning issues and rezoning applications and if necessary organising Official Objections to COJ; monitoring our Utilities (street lights, sewage, roads, storm-water drains etc.); representation of Woodmead / Khyber Rock at various Agencies and Forums such as City of Joburg, Sandton Community Police Forum, Ward 106 Council Committee, Road Closure Boards and other forums including monthly meetings with our preferred security company and fortnightly meetings with Operational staff of iMvula & 24/7 Security.

As from May 1st, 2016 the Preferred Armed Response company for the Woodrock area is 24/7 Security. This appointment was made subsequent to eight well-known security companies in Sandton being formally invited to Tender. The decision became effective after extensive negotiations, resident Open meetings at CCJ, further meetings attended by Street/Complex Captains with a final ten-man Committee entering into a formal voting procedure. Total transparency was observed during the entire process.

Special rates have been negotiated to meet the varying needs of residents and these cater for stand-alone homes, homes within Complexes, lock-up-and-go situations and Senior Citizen discounts. We have promised an 80% uptake on individual Armed Response contracts which allows us one 24/7 dedicated Armed Response vehicle on a complimentary basis. Obviously, WE REALLY NEED RESIDENTS to help us meet these obligations.

Please note Security Industry increases take effect Nationally every September & we are forced to increase our fees annually to at least meet these national increases as they occur.

Finally, note that iMvula Security currently provide a complementary service for our boom operations, as well as a training facility for our Domestic Watch program.
