August 2018 is almost over and there are some really important issues that need to be shared.

Most importantly is our **<u>ROAD CLOSURE</u>** renewal application.

Time is running away from us in this regard and last night we had a visit from Metro regarding the validity of the Road Closure after they had received a complaint on Thursday 16<sup>th</sup> August in this regard. The on-site Metro Inspector was happy with our Operation and our various controls but urged us to finalise the Renewal process to prevent any further complications. # TRAFFIC CALMING

As those residents who are on the Woodrock What's App groups are aware, there is much discontent regarding the increase in traffic through our area and more especially the seemingly total lack of regard for speed limits and stop streets. We have requested TRAFFIC CALMING measures and suggested additional speed humps along lower Lincoln as well as Packard as well as a traffic circle at the Lincoln/Plymouth intersection.

This issue has been at the forefront of our many requests to the City, supported by the Ward 106 Committee and Councillor, and it would now seem that a TRAFFIC SURVEY is imminent.

My unofficial count of traffic passing through the area recently was 237 cars within a <sup>3</sup>/<sub>4</sub> hour period starting 11.00hrs on Monday 13<sup>th</sup> August (we were replacing the broken plant pot at Riley Road booms which had been damaged by a passing truck). From this count we can estimate that approximately 3000 vehicles pass through our area in a 12hour daytime period.

Metro (JMPD) have commented on the fact that we do not have enough traffic warning signs within the area, and to that end we trust that the City will correct this omission. We are also, once again, requesting that road painting be done, especially the centre-road lines and demarcation. Recently JRA did repaint the STOP SIGNS but were unable to complete all markings due to Budget restraints.

## **FINANCES**

There was a 10% increase to fees at the start of our Financial year (March/2018) - <u>the</u> <u>first in FOUR YEARS</u>.
